# **Long Methodology Statement**

Effective sample size after weighting applied: 366

Margin of error associated with effective sample size: ±4.3% (90% confidence level) Variables used in weighting & weighting method used: Age x gender x location, previous vote, Rim weighting

Full question text, responses categories and randomisation: See below

Proportion of landline/mobile completed interviews: n=17 by landline / n=380 mobile

Source of online sample: Not applicable

**Positioning of voting intention questions in questionnaire?** Immediately after demographics

**2PP calculation method:** Calculated according to preferences flows at previous elections **How were undecided voters handled?** Undecided respondents who answered "don't know" were asked a leaner question which also included a "don't know" option. Those who answered don't know were excluded from published voting intention figures but not from the survey. 7% were thus excluded from published voting intention figures.
