Long Methodology Statement

Effective sample size after weighting applied: 325

Margin of error associated with effective sample size: $\pm 4.6\%$ (90% confidence level)

Variables used in weighting & weighting method used: Age x gender x location, education, Rim weighting

Full question text, responses categories and randomisation: See below

Proportion of landline/mobile completed interviews: n=21 by landline / n=371 mobile

Source of online sample: Not applicable

Positioning of voting intention questions in questionnaire? Immediately after demographics

2PP calculation method: Calculated according to preferences flows at previous elections

How were undecided voters handled? Undecided respondents who answered “don’t know” were asked a leaner question which also included a “don’t know” option. Those who answered don’t know were excluded from published voting intention figures but not from the survey. 8% were thus excluded from published voting intention figures.
